***IMPORTANT ADDITIONAL INFORMATION REGARDING YOUR BOOKING. You must not accept the booking unless you understand and agree with the following terms and conditions.**

We are Adonde Travel Inc. and we look forward to the opportunity to act as your booking agent for the Presbyterian Pilgrimage Tour. The terms "we", "us" and "our" refer to Adonde Travel, Inc. The term "you" refers to the customer booking the tour.

Adonde Travel, Inc. sells various travel related products on behalf of transport service providers, including, but not limited to hotel, tours, and airlines. Adonde Travel, Inc. does not own, operate, manage or control these independent suppliers of services and is not liable for their acts or omissions. We have no responsibility for these services, nor do we have the authority to make any warranty or representation regarding their standard. A request cannot be guaranteed. All bookings are subject to the terms and conditions and limitations of liability imposed by these travel service providers. You understand that your legal recourse is against the specific provider not Adonde Travel, Inc.

Important Conditions

Prices are subject to increase prior to the time you make full payment. Prices are not subject to increase after you make full payment, except for charges resulting from increases in government-imposed taxes or fees.

Baggage Disclaimer and Fees

Additional fees for baggage may apply. Please contact United Airlines or refer to its website for detailed information regarding their checked baggage policies.

Although every effort is made to handle passengers' luggage as carefully as possible, Adonde Travel, Inc. is not responsible for and does not assume liability or accept claims for loss of or damage to luggage due to breakage, theft or wear and tear through hotel and group carrier handling.

Changes/Revisions

Where a change requested by you to your travel arrangements is permitted and possible, our standard service fees will apply in addition to any additional Supplier charges. Air is 100% nonrefundable once the ticket has been issued.

Changes to name details are not allowed by many Suppliers. While we will endeavour to make such a change if necessary, please bear in mind that most Suppliers treat a name change as a cancellation, to which standard conditions and charges would apply.

Cancellations

Cancellations of confirmed bookings result in penalties and fees assessed by travel suppliers. Air is 100% nonrefundable once the ticket has been issued.

If cancelled prior to being paid in full the following cancellation fees will apply:

- \$250.00 penalty per person.
- Airline ticket is non-refundable

If cancelled once final payment has been made, it is 100% nonrefundable.

Maps shown on tour pages are current at the time of printing and may not reflect actual tour routing should the tour change. Photos shown on tour pages are reflective of the area(s) visited, but may not be included in the actual tour itinerary.

Passports

All individuals departing from the United States of America must be in possession of a valid passport with a validity of at least six months from return date. It is your responsibility to ensure that you have valid travel documentation, including but not limited to passports and visas, which meet the requirements of immigration and other government authorities at every destination. You are responsible for confirming with the United States Department of State or representative government agency of the country to which you are traveling to confirm the requirements for visas and/or other requirements for admission to your destination. Any fines, penalties, payments or expenditures incurred as a result of such documents not meeting the requirements of those authorities will be your sole responsibility.

Travel Documents

Travel documents including, without limitation, airline tickets, hotel vouchers, tour vouchers or any other document (whether in electronic form or otherwise) are used to confirm an arrangement with a service provider. Travel documents may be subject to certain conditions and/or restrictions such as, but not limited to, being nonrefundable, non-date-changeable, and subject to cancellation and/or amendment fees. Travel documents cannot be transferred to another person to use. All airline tickets must be issued in the name of the passport/photo identity holder. An incorrect name on a booking may result in an inability to use that booking and the booking being cancelled. Any errors in names, dates and timings may result in an inability to use that booking and the booking being cancelled. Any errors in names, dates and timings on your documentation will be your responsibility if not advised at the time of booking.

Health and Special Requirements

It is your responsibility to ensure you are aware of any health requirements for your travel destinations and to ensure that you carry all necessary vaccination documentation. Please advise Adonde Travel, Inc. of any special requirements you may have, for example, special meals, medical requirements and so on.

TRAVELERS NEEDING SPECIAL ASSISTANCE

You must report any disability requiring special attention to Adonde Travel at the time the reservation is made.* Adonde Travel, Inc. will make reasonable efforts to accommodate the special needs of tour participants. Such participants, however, should be aware that the Americans with Disabilities Act is inapplicable outside of the United States and facilities outside the United States for disabled individuals are limited.

It is strongly recommended that persons requiring assistance be accompanied by a companion who is capable of and totally responsible for providing the assistance. Neither Adonde Travel, Inc. nor its personnel, nor its suppliers, may physically lift or assist clients into transportation vehicles. If a traveler thinks he or she might need assistance during a trip, he or she should call Adonde Travel, Inc. to determine what assistance might reasonably be given. Adonde Travel, Inc. cannot provide special individual assistance to tour members with special needs for walking, dining or other routine activities.

Refusal of Service

Service providers reserve the right to refuse service to travelers at their sole discretion and including without limitation if the traveler:

- Lacks proper documentation for the country of destination;
- Has a contagious disease;
- Is under the influence of alcohol, drugs or narcotics; and/or
- Manifests disruptive and/or unruly behavior.

Adonde Travel, Inc. assumes no liability for the acts of the service provider in refusing service.

Hazardous Materials Disclosure

Federal law forbids the carriage of hazardous materials aboard aircraft in your luggage or on your person. A violation can result in five years' imprisonment and penalties of \$250,000 or more (49 U.S.C. 5124). Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives and radioactive materials. Examples: paints, lighter fluid, fireworks, tear gases, oxygen bottles and radio-pharmaceuticals.

There are special exceptions for small quantities (up to 70 ounces total) of medicinal and toilet articles carried in your luggage and certain smoking materials carried on your person. If this occurs, every effort will be made to offer alternate dates and/or programs.

Published times on itineraries are as accurate as possible but subject to change due to traffic, weather, mechanical and any other conditions beyond Adonde Travel, Inc.'s control that prevent Adonde Travel, Inc. from operating as scheduled. Adonde Travel, Inc. expressly disclaims any liability for any damages that may be incurred for any changes, cancellations or delays on the tour.

All rates on foreign tours are subject to fluctuations of currency and may be changed when necessary without advance notice prior to deposit.

All rates published are per person as indicated and are based on double occupancy when only one rate is shown. Reservations will be accepted subject to availability at the time of a request and will be considered confirmed only upon receipt of a minimum deposit.

Responsibility

We always do our best to make sure your travel arrangements are satisfactory. However, Adonde Travel, Inc. and its employees, shareholders, subsidiaries, affiliates, officers, directors, successors, agents, and assigns do not own or operate any entity which provides goods and services for your travel including without limitation, lodging facilities, airline, vessel, motor coach, or other transportation companies, guides or guide services, local ground operators, providers or organizers of optional excursions, food service providers, etc. All such persons and entities are independent contractors and are in no way affiliated to Adonde Travel, Inc.

Liability

Adonde Travel, Inc. is not liable for any negligent or willful act or failure to act of any travel service provider or of any third party. In addition and without limitation, Adonde Travel, Inc. is not responsible for any injury, loss, death, inconvenience, delay, or damage to person or property in connection with the provision of any goods or services whether resulting from, but not limited to, acts of God or force majeure, illness, disease, acts of war or civil unrest, insurrection or revolt, animals, strikes or other labor activities, criminal or terrorist activities of any kind, overbooking or downgrading of accommodations, mechanical or other failure of airplanes or other means of transportation, or for any failure of any transportation mechanism to arrive or depart on time. If due to weather, flight schedules or other uncontrollable factors you are required to spend additional night(s), you will be responsible for your own hotel, transfers and meal costs. Baggage is entirely at owner's risk. You may see the name Adonde Travel, Inc. affixed to motor vehicles, on signs around the hotel or elsewhere. This use of our name is purely for reasons of identification and does not denote ownership, supervision, or control by Adonde Travel, Inc. in any way. You specifically agree that Adonde Travel, Inc. is not liable for any consequential loss or damage.

This Agreement shall be governed by the laws of the State of Texas without regard to its conflicts of laws principles. If any provision of this Agreement is found to be invalid, illegal or unenforceable, the enforceability of the remaining provisions will not in any way be affected or impaired.
